

**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE CIVIL AVIATION AUTHORITIES OF
MONTENEGRO AND ALBANIA**

The Civil Aviation Agency of Montenegro and the Civil Aviation Authority of Albania, hereinafter referred to as "the Parties",

Considering the common interest of the Parties to achieve a high uniform level of civil aviation standards in accordance with ECAA Agreement commitments,

Considering the necessity of both Parties of coping with new challenges and introducing improvements in the framework of achieving the aim of entering the European Common Aviation Area,

Have agreed to facilitate their cooperation in civil aviation as follows:

I. General Provisions

1. The present Memorandum of Understanding (hereinafter referred as the MoU) is aimed to enhance safety level standards in the civil aviation sector in each respective Party's country, by means of sharing information, experiences and logistic support whereas each of the Parties plays an important part in achieving this goal.
2. The present MoU pays the due regard to the Chicago Convention and does not supersede or prejudice existing forms of cooperation among the Parties, as long as they remain in force.

II. Scope and objectives

This Memorandum of Understanding (MOU) sets forth the understanding and intention of both parties to provide a framework for co-operation between them through offering assistance and sharing of air safety expertise.

III. Co-operation areas

Both Parties agree to cooperate in the following areas:

A) Programs, examinations and licensing:

- Exchange of technical expertise in the framework of developing national exams base related to FCL, Part-66 etc;
- Development of joint training programs and arrangement of mutual trainings for both authorities' personnel;
- Arrangement of on-job training for both authorities;

- Joint Commissions- inspection teams for oversight of schools, operators, AME/AMS and SAFA, when requested by the party that has to perform the inspection.

B) Flight operations, airworthiness and aeronautical register

- Exchanging materials and expertise when needed for drafting procedures related to oversight of issuance, extension and change of certificates and endorsements associated with flight operations, airworthiness and register;
- Exchanging materials and expertise when needed for drafting internal Manuals used by the inspectors within their area of work;
- Cooperation on the implementation and utilization of electronic data base - system for aircraft registry.

C) Airports

- Assist each other in regard to registration, oversight and certification of airports.

E) NSA and ATM matters

Assist each other in the oversight and certification process of the service provider.

IV. Cooperation Activities

In order to achieve the objectives of this MoU, Parties agree to perform the following activities:

- a) establishment of mechanisms for consultation, coordination, cooperation and sharing of information;
- b) organization of joint working groups;
- c) organization of joint meetings, seminars, conferences, etc;
- d) establishment of joint list of experts in the areas of licencing, certification and aeronautical medicine;
- e) organization of any other kind of assistance concerning aviation safety issues.

V. Consultations

In the spirit of solidarity and cooperation, the Parties will consult each other from time to time to ensure the implementation of the present MoU.

VI. Entry into Force

The present MoU drawn up in two (2) originals in the English language shall enter into force upon signature of both Parties on the date of the latest signature.

VII. Amendment and Termination of the MoU

1. The present MoU may be amended subject to mutual agreement of both parties.
2. The present MoU shall remain valid until either party provides a written notification to the effect of its termination.
