1. The Albanian National Conversion Report, documents the national requirements for the issue of military licenses. It compares the requirements for the training of military air traffic controllers and civil air traffic controllers. It contains the results of the gap analysis and the possible credits for the military training syllabi provided by the Albanian military in accordance with the MoU with the Albanian Aviation Authority.
